## SECTION 4. First aid measures.

### 4.1. Description of first aid measures.

**EYES:** Remove contact lenses, if present. Wash immediately with plenty of water for at least 30-60 minutes, opening the eyelids fully. Get medical advice/attention.

#### GENERAL INFORMATION

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. Always wear full fire prevention gear. **8.2. Exposure controls.**
